The Davidson County Board of Commissioners met on Tuesday, July 14, 2009, in the Commissioners' Meeting Room, Governmental Center at 7:00 P.M. for a special called meeting and public hearing.

Guy Comman, Planning and Zoning Director, thanked Dr. Fred Mock for his help and his time.

4. Community Development Block Grant-Small Business Entrepreneurial Assistance

a. <u>Loflin Fabrication, Inc. - Emmons Township</u>

On a motion by Commissioner Truell and a second by Commissioner Potts the Board voted unanimously 7-0 to open the public hearing to receive public input on the submission of a grant application to the North Carolina Department of Commerce, Division of Community Assistance, for a Small Business & Entrepreneurial Assistance grant to assist Loflin Fabrication in obtaining up to \$250,000 of grant money to fund the construction of a water and sewer system, and the construction of additional manufacturing buildings. Robert Hyatt provided details of the purpose for the public hearing and projects that have been brought forward.

Barney Hill addressed the Board in opposition to the grant application.

Greg Loslin addressed the Board in favor of the grant application and provided a diagram of the proposed expansion.

Michael Boaz, with Handy Sanitary District, spoke in favor of the grant and provided information on the requests in the project.

Steve Googe of Davidson County Economic Development spoke in favor of the grant application and provided information.

Robert Hyatt provided clarifications and information on guidelines.

Greg Loflin addressed the Board with information on the responsibility he has in accepting the grant. He noted that he did not consider the grant to be free money.

Barney Hill spoke in opposition.

Steve Googe spoke on the purpose of the public hearing.

Robert Hyatt, again, clarified the details of holding the public hearing.

On a motion by Commissioner Potts and a second by Vice Chairman Watford the Board voted unanimously 7-0 to close the public hearing.

The Board agreed to move forward with the second public hearing.

On a motion by Vice Chairman Watford and a second by Commissioner Potts the Board voted 6-1 to approve the consent agenda; Commissioner Kepley voted "No.".

On a motion by Commissioner Potts and a second by Commissioner Walser the Board voted unanimously 7-0 to schedule a public hearing for September 14, 2009, 7:00 P.M., Commissioners' Meeting Room, Governmental Center and amend the meeting schedule to eliminate the August 3, 2009 public hearing.

Schedule Public Hearing – 2009-2010 Rural Operating Assistance Program (ROAP)

Grant Application by George Hodges, Traffic Manager

On a motion by Commissioner Truell and a second by Commissioner Kepley the Board voted unanimously 7-0 to schedule a public hearing to receive information and public input on the 2009-2010 ROAP grant application for August 11, 2009 at 7:00 P.M. in the Commissioners' Meeting Room, Governmental Center, 913 Greensboro Street, Lexington, North Carolina. 5. <u>Economic Development Incentive Policy by Steve Googe, Davidson County Economic Development Director</u>

Steve Googe proposed an expansion of guidelines for providing incentives to businesses. Mr. Googe provided the details of the grants to be offered. It was noted that there is the effort to assist existing businesses as well as to attract new industry.

On a motion by Commissioner Potts and a second by Vice Chairman Watford the Board voted unanimously 7-0 to accept the changes. (See Exhibit 5)

6. Acquisition of Real Property by Chuck Frye, County Attorney

County Attorney Chuck Frye provided the details of the Offer to Purchase on the Davidson Academy project for \$1,825,000. Mr. Frye noted that the change from the previous Offer to Purchase is in the time of closing.

Commissioner Potts and Vice Chairman Watford expressed their opposition to the acquisition of the property.

Commissioner Walser noted the need for the property for the County and need of the facility for senior citizens, Parks and Recreation, and in particular for the Special Olympics program.

Commissioner Truell noted that he did not feel it is the right time to purchase the property due to the economy and that people do not have the money to pay more taxes.

Commissioner Kepley spoke in favor of the acquisition, noting that it is a golden opportunity. He pointed out the asset in having the buildings and gymnasium, and with land there as a bonus for expansion.

Commissioner Dunn noted that the building in question is for the people of the County and it would be of great benefit for our seniors.

Chairman McClure noted that the County has kept a line on the budget and taxes have not been raised. He further noted the amount of money available in County funds.

Robert Hyatt spoke in favor of the acquisition of the property, noting the cost of maintenance on the older facilities.

On a motion by Commissioner Potts and a second by Vice Chairman Watford the Board voted 3-4 to deny acquisition of the property; Commissioner Kepley, Commissioner Dunn, Chairman McClure, and Commissioner Walser voted "No." The motion to deny failed.

Commissioner Walser made the following motion, "I move that we enter into the proposed Offer to Purchase and Contract of Sale with Davidson Academy for the purchase of that 10.815 acre tract located at 555 West Center Street Extension and the personal property and furnishing of Davidson Academy, in Lexington, for the purchase price of \$1,825,000.00 and upon such further terms and conditions as are set out in the proposed Offer to Purchase and Contract." The motion received a second by Commissioner Kepley. Upon a vote, the motion carried 4-3; Commissioner Potts, Commissioner Truell, and Vice Chairman Watford voted "No."

Qualified School Construction Bonds by County Manager Robert Hyatt

Robert Hyatt and Zeb Hanner presented information on the application for the Qualified School Construction Bonds. Mr. Hanner provided details on the amount of interest and the 12-15 year payback. Discussion followed.

On a motion by Vice Chairman Watford and a second by Commissioner Kepley, the Board voted 6-1 to submit an application for the Qualified School Construction Bonds; Commissioner Potts voted "No."

On a motion by Commissioner Walser and a second by Commissioner Kepley the Board voted unanimously 7-0 to go into Closed Session for matters of real estate and attorney/client.

County Attorney Chuck Frye reported discussion of real estate and attorney/client with no action taken.
