On a motion by Commissioner Akins and a second by Vice Chairman Potts the Board voted unanimously 7-0 to adopt the consent agenda with the exception of H.4. Retirement for Elected Officials.

4. Retirement for Elected Officials by Vice Chairman Larry W. Potts

Commissioner Truell inquired how many counties have the program and why the program would be retroactive to 1990. Discussion followed.

Chairman McClure replied that his inquiries to the State rendered no records to give substantial figures as to how many counties have a retirement program.

Vice Chairman Potts noted that there are only three commissioners since 1990 that would qualify for the program.

Commissioner Watford stated that he is opposed to the program.

Commissioner Akins noted that it would be a good benefit for Commissioners.

On a motion by Commissioner Potts and a second by Commissioner Sink the Board voted 4 to 3 to approve the Retirement Program for Elected Officials; Commissioners Truell, Watford, and Chairman McClure voted "No." (Exhibit 4)

On a motion by Commissioner Akins and a second by Commissioner Watford the Board voted unanimously 7-0 to adopt the Resolution to Establish Procedure for the Construction of New Schools and New Buildings for the Davidson County School Administrative Unit, the Lexington City School Administrative Unit, the Thomasville City School Administrative Unit and Davidson County Community College. 9. Architectural Firm and Budget for West Davidson Area Elementary School Project by

On a motion by Vice Chairman Potts and a second by Commissioner Sink the Board voted unanimously 7-0 to adopt the following resolution:

RESOLVED that the Davidson County Board of Commissioners ("County Commissioners")

approves the selection and engagement of Martin, Boal, Anthony, Johnson, Architects, by the Davidson

County Board of Education ("Board of Education"), along with the funds necessary to hire said architects

for the purpose of designing the new West Davidson Area Elementary School. This resolution is made

pursuant to that certain agreement by and between the County Commissioners and the Board of Education

dated April 22, 2003. (Exhibit 9)

- 10. Comprehensive Annual Financial Report by Martin Starnes & Associates, CPAs

 The Board received the Comprehensive Annual Financial Report prepared by Martin Starnes &

 Associates, CPAs, and an accompanying slide presentation from Chris Costner. (Exhibit 10)
 - Renewal of Lease for Probation/Parole by Dwayne Childress, Purchasing Director
 The Board received a lease agreement between Davidson County and Dr. Kwan for

Probation/Parole facilities to be considered for renewal from Dwayne Childress. Discussion followed concerning the term of the lease and County maintenance responsibilities.

Bill Clutter noted that Public Works and Services is not presently maintaining heat and airconditioning or flooring in the Kwan facility.

Vice Chairman Potts recommended that the lease agreement be renegotiated to reflect that any damage by the County to the facility will be repaired by the County but other repairs are the responsibility of Dr. Kwan and that the term of the lease is for one year.

On a motion by Vice Chairman Potts and a second by Commissioner Watford the Board voted unanimously 7-0 to re-negotiate the terms of the property lease with Dr. H.L. Kwan for the Probation/Parole facility for one year with stipulations of County maintenance. (Exhibit 11)

Commissioner Walser presented a proposal for use of old voting machines. Discussion followed concerning use of the machines in other places.

Commissioner Walser requested that the County Manager and Director of Elections research the proposal. (Exhibit 11)

Trading Path Association Update by Commissioner Walser

Commissioner Walser presented information on The Trading Path at Abbotts Creek.

Commissioner Walser noted the potential of the trading path becoming an attraction for tourism.

On a motion by Vice Chairman Potts and a second by Commissioner Watford the Board voted unanimously 7-0 to go into Closed Session for matters of Attorney/Client, Real Estate, and Economic Development.

On a motion by Commissioner Truell and a second by Commissioner Watford the Board voted unanimously to return to Open Session.

County Attorney Robert Hedrick reported discussion of Attorney/Client, Real Estate, and Economic Development matters with no action taken.

AMENDMENT TO AGENDA

On a motion by Vice Chairman Potts and a second by Commissioner Akins the Board voted unanimously 7-0 to amend the agenda to schedule public hearings for economic development incentives for two industries.

On a motion by Vice Chairman Potts and a second by Commissioner Truell the Board voted unanimously 7-0 to schedule a public hearing for January 10, 2006, 7:00 P.M., Commissioners' Meeting Room, Governmental Center, 913 Greensboro Street, Lexington, for an economic development incentive to *PPG* (.0027 x \$4,500,000 for five years not to exceed \$12,150 per year).

On a motion by Commissioner Watford and a second by Commissioner Sink the Board voted unanimously 7-0 to schedule a public hearing for January 10, 2006, 7:00 P.M., Commissioners' Meeting, Governmental Center, 913 Greensboro Street, Lexington, for *Advanced Motorsports Coatings* (.0027 x \$1,500,000 for four years not to exceed \$4,050 per year).
