Presentation on Activities of Piedmont Area Regional Transportation (PART) by Brent

McKinney

Brent McKinney presented some facts about the area involvement with PART. He included in his report that the ridership is definitely growing and is 13% above last year. He noted that PART is responsible for 13million passenger miles of people off the road and the buses average 8.4 passengers per bus. Mr. McKinney went over the routes for the buses and the demand for ridership on those routes. He stated that there will be a 25% increase in the fare and some routes will have to be cut. He then emphasized the need for additional funding from local entities and noted that Davidson County has approximately 34,000 riders. Mr. McKinney stated that approximately 350,000 gallons of fuel are used per year by PART. (Exhibit 2)
